### 25 NEWS MEMBERS JOIN FOR 25TH ANNIVERSARY

The 25<sup>TH</sup> Anniversary Campaign has enrolled 25 new members as of August 31, 2008, symbolic of marking the organization's 25<sup>th</sup> Anniversary in 2009. The campaign was formally organized into a 60-member National Membership Committee co-chaired by John A. Payiavlas, former L100 Chairman and Constantine G. Caras, the current Vice Chairman, just this summer. "The committee set a goal for 63 members for 2008 with most membership events scheduled for the fall, so we feel confident that we will meet that goal," said Payiavlas. Ultimately, the organization is aiming for 1,000 members from the current membership of 771. The campaign will continue through 2010.

Regional and Metropolis Chairmen of the 25<sup>th</sup> Anniversary Campaign met at Leadership 100 offices at the Olympic Tower in New York City in July to plan events for the Direct Archdiocesan District of New York and the Metropolis New Jersey and to assist Paulette Poulos, Executive Director (Interim), in scheduling events across the nation over the remainder of 2008. Louis Nicozisis, Eastern Regional Chairman and Peter J. Pappas, Archdiocesan District Chairman met with John Catsimatidis, George Komodikis, Kostas Pouloupoulos and George Tsandikos, Archdiocesan District Co-Chairmen, and Kassandra Romas and John Kusturiss, Metropolis of New Jersey Co-Chairmen

The following membership recruitment events have been scheduled: Thursday, September 18 – Philadelphia; Thursday, October 9, Boston; Thursday, October 23 – New York; Friday, September 26 – Cleveland; Thursday, November 13 – Chicago; and Thursday, November 20 - Las Vegas.

The Direct Archdiocesan District led the way with seven new members, followed by the Metropolis of San Francisco with five. The Metropolises of Pittsburgh, Denver and Atlanta recruited three members each, followed by the Metropolises of Chicago and New Jersey with two members each.
